

Terms & Conditions - Net loss cover program

For a limited time, referred clients under the **Introducing Broker (IB)** *FXLearning (2021134)* are eligible to receive a 50% net loss cover, up to 10% of the deposit subject to these Terms & Conditions.

1. How it works:

- 1.1. This promotion is applicable to referred clients of those Introducing Brokers (IBs) that are approved by GO Markets for this promotion.
- 1.2. Clients need to opt in to the promotion via a specific google form and agree to these terms and conditions before placing their first trade.
- 1.3. Eligible clients will receive a 50% net P/L cover, capped to 10% of total net deposit.
- 1.4. To be eligible for the promotion, clients are required to execute a minimum of ten (10) trades. There is no minimum lot size required.
- 1.5. Clients must not have a prior deposit history on any of their accounts with GO Markets. Additional accounts are not counted for this promotion.
- 1.6. Each client is allowed only one (1) claim under this promotion.
- 1.7. Withdrawals from the account, including internal transfers are not permitted during the promotion period. In case of a withdrawal during the promotion period, the offer will be revoked.
- 1.8. Net loss cover will be credited to the same trading account within 1 month after the promotion end date.

- 2.2. This promotion is limited to MT4, MT5, cTrader and Trading View accounts exclusively. PAMM, Copy Trading, cTrader Copy are not eligible.
- 2.3. Only persons who can perform legally binding contracts under the laws applicable in their country of residence may participate in the Program.
